Tis the Season!

The holiday season is upon us and no matter how you celebrate, winter has invited itself to your home. As you and your family prepare, please remember the dangers that certain supplies and conditions bring to your pets.

As the temperatures drop, humans stock up on supplies such as salt, ice melt and antifreeze. While these items help keep you and your family safe, they pose serious risks for your pets. Salt and certain types of ice melt are toxic to dogs and cats (lethal to those with kidney disease), and can cause chemical burns to paws and tracheas. Many stores carry pet-safe ice melt—an option you and your neighbors should consider using. Antifreeze (ethylene glycol) is another substance that is toxic, and can be fatal, when ingested. Cats and dogs are attracted to the smell and like the taste, so ensure that car radiators are not leaking fluid in the garage or driveway. Also ensure antifreeze containers are tightly sealed.

Besides supplies, cold temperatures are also a concern for all pets. Ensure habitat and home temperatures are kept at a safe and comfortable level for all residents, not just the human ones. Time spent outdoors should be shortened on frigid days, especially for small, short-haired or senior pets. When you shovel the driveway and sidewalk for your safe passage, be sure to dig out a path for your pet as well. As a reminder, dogs can lose traction on ice, so be especially watchful of older animals. Boots can be purchased to help with traction and ice sensitivity. And after you and your pet take that abbreviated trip outside, be sure to wash/wipe paws free of any sediment.

Celebrate the holiday season and enjoy the winter weather in all of its splendor and glory. Knowing the associated pet health and safety risks will make you and your family even more prepared. Your pet will thank you for it!

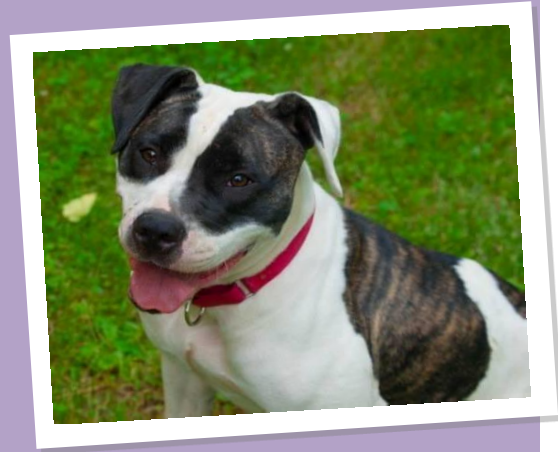

Pesky Parasites, Perish

Thanks to you our generous donors, we are able to provide a new state-of-the-art program at the Shelter; parasite application at intake for kittens and puppies older than 4 weeks, adult cats, dogs and rabbits.

Dr. Suzy Broadhurst, the Animal Shelter Veterinarian from Pender, has put together an excellent protocol program and will be working with Shelter management and staff to implement it. The protocol calls for a number of medications. One medication will help control heartworms, roundworms, hookworms, whipworms, tapeworms, and flea infestations. The Center for Disease Control lists "roundworms" as one of the 5 most neglected parasites, yet it is potentially harmful to humans, especially children. By purging internal and external parasites it will reduce the amount of interventional medical care; saving time, money and unnecessary suffering of animals. We are excited about the benefits this new program will have for the animals at the Shelter.
